**RETURNS:** ALL RETURNS MUST BE MADE WITHIN 60 DAYS. NO CREDIT WILL BE ISSUED FOR SHIPPING CHARGES, EXCEPT IN CASES OF OUR ERROR. RETURNS COULD BE SUBJECT TO A RESTOCKING FEE

**TERMS:** OUR TERMS ARE NET ON RECEIPT. INTEREST WILL BE CHARGED ON ALL OVERDUE ACCOUNTS AT THE RATE OF 1 1/2% PER MONTH

**CUSTOM ORDERS:** CUSTOM ORDERS ARE NOT CANCELABLE OR RETURNABLE. A NON-REFUNDABLE DEPOSIT IS REQUIRED ON ALL CUSTOM ORDERS.

**LOSS AND/OR DAMAGE IN TRANSIT**

**PARCEL POST:** CLAIMS FOR DAMAGED MERCHANDISE MUST BE REPORTED TO US WITHIN 24 HOURS. WE WILL INFORM YOU HOW TO RETURN THE SHIPMENT. WE WILL REPLACE THE ITEMS AND FILE A CLAIM FOR THE DAMAGE

**UPS:** CLAIMS FOR DAMAGED MERCHANDISE MUST BE REPORTED TO US WITHIN 24 HOURS. SAVE ALL PACKAGING AND PREPARE THE SHIPMENT FOR RETURN TO US. WE WILL ARRANGE FOR UPS TO PICK UP THE DAMAGED PACKAGE AND A CLAIM WILL BE FILED FROM OUR OFFICE. REPLACEMENT FOR DAMAGED ITEMS WILL BE SENT AFTER AN INSPECTION IS MADE.

**COMMERCIAL CARRIER OR TRUCKING COMPANY:** ACCORDING TO FEDERAL ICC REGULATIONS, SHIPMENTS BECOME YOUR PROPERTY WHEN RECEIVED BY THE CARRIER. OUR LIABILITY CEASES UPON RECEIPT BY THE CARRIER WHO SIGNS OUR BILL OF LADING ATTESTING THAT THE SHIPMENT WAS IN GOOD ORDER WHEN PICKED UP. FOR YOUR PROTECTION, SIGN ONLY FOR THE QUANTITY OF CASES RECEIVED, AND IF DAMAGE IS APPARENT HAVE THE DRIVER MAKE A NOTATION AND SIGN THE WAYBILL. IF YOU DISCOVER DAMAGE WHILE UNPACKING NOTIFY THE CARRIER IMMEDIATELY AND FILE A CLAIM FOR "CONCEALED DAMAGE". IT IS YOUR RESPONSIBILITY TO NOTIFY THE CARRIER AND REQUEST AN INSPECTION. CLAIMS FOR BREAKAGE OR DAMAGE IN TRUCK TRANSPORTATION CANNOT BE ACCEPTED BY US.
